

**The following are the schedule of activities:**

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Revised Implementing Rules and Regulations of Republic Act No. 9184 otherwise known as the Government Procurement Reform Act. Only bids from bidders which are declared "passed" will be evaluated. The contract shall then be awarded to the lowest Calculated and Responsive Bidder (LCRB) who has been determined as such during the post-qualification procedure.
